PLEASE TAKE NOTICE that on July 12, 2006 (the "Confirmation Date")<sup>1</sup>, the Bankruptcy Court entered an order (the "Confirmation Order") confirming the above captioned Debtor's First Amended Plan of Reorganization [D.I. 126] (the "Plan"). The Confirmation Order is on file with the Clerk of the Bankruptcy Court and may be inspected during normal business hours at the Office of the Clerk of the Bankruptcy Court, 3rd Floor, 824 Market Street, Wilmington, Delaware 19801. Copies of the Confirmation Order can also be found at Docket No. 126 on the Bankruptcy Court's website ([www.deb.uscourts.gov](http://www.deb.uscourts.gov)) or obtained by making a written request to Matthew B. McGuire, Esq. at Buchanan Ingersoll & Rooney PC at the address listed in the signature block below. You are encouraged to review the Confirmation Order in its entirety.

PLEASE TAKE FURTHER NOTICE that unless otherwise ordered by the Bankruptcy Court, requests for payment of Administrative Claims,<sup>2</sup> with the exception of Final Fee Applications, must be filed and served (as set forth below) no later than **August 11, 2006 at 4:00 p.m.** (the "Administrative Claims Bar Date").

PLEASE TAKE FURTHER NOTICE that any person that is required to file and serve a request for payment of an Administrative Claim by the Administrative Claims Bar Date, but fails to timely file and serve such request, shall be forever barred, estopped and enjoined from asserting such claim or participating in distributions under the Plan on account thereof.

<sup>1</sup> Unless otherwise defined, all capitalized terms used herein shall have the meaning ascribed to them in the Plan.

<sup>2</sup> Pursuant to the Plan, "Administrative Claim" means any right to payment constituting a cost or expense of administration of the Chapter 11 Case under Sections 503(b) and 507(a)(1) of the Bankruptcy Code, including, without limitation, any actual and necessary costs and expenses of preserving the estate of the Debtor, any actual and necessary costs and expenses of operating the business of the Debtor, any costs and expenses of the Debtor in Possession in connection with the administration and implementation of the Plan, any indebtedness or obligations incurred or assumed by the Debtor in Possession in connection with the conduct of its business, including, without limitation, for the acquisition or lease of property or an interest in property or the rendition of services, all compensation and reimbursement of expenses to the extent allowed by the Bankruptcy Court under Sections 330 or 503 of the Bankruptcy Code and any fees or charges assessed against the estate of the Debtor under Section 1930 of chapter 123 of Title 28 of the United States Code.
