2. I am authorized to make this affidavit on Sullivan Hazeltine's behalf. I have personal knowledge of the matters stated herein except where I have indicated that I relied on specific information.

Rules 2014(a) and 2016(b) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Rules 2014-1 and 2016-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States of Bankruptcy Court for the District of Delaware (the "Local Rules"), in support of the application Moll Industries, Inc. and its affiliated debtors, debtors and debtors-in-possession in the above-captioned chapter 11 cases (the "Debtors"), for an order pursuant to section 327(a) and 1107 of the Bankruptcy Code, authorizing the employment and retention of Sullivan Hazeltine as counsel for the Debtors *nunc pro tunc* to the Petition Date (the "Application") (Docket No. 40).


4. I submit this Supplemental Declaration to supplement my prior Declaration, filed in support of the Application, which was attached to the Application.

In addition to the disclosures made in the Declaration, Sullivan Hazeltine discloses that it has represented and continues to represent NexPak Corporation and certain of its affiliates (the "NexPak Debtors") as debtors in bankruptcy cases pending in the United States Bankruptcy Court for the District of Delaware, jointly administered as Case No. 09-11244. Certain of Debtor Moll Holdings, LLCs' equity holders are, or are related to, certain of the equity holders of NexPak Corporation prior to June 2, 2010, the effective date of the NexPak Debtors' plan of liquidation. In addition, (i) certain of the Debtors' pre-petition secured lenders are, or are affiliates of, certain of the NexPak Debtors' pre-petition secured lenders and (ii) NexBank, SSB, administrative agent for the Debtors' pre-petition secured lenders, is the administrative agent for the NexPak Debtors' pre-petition secured lenders. The matters with respect to which Sullivan Hazeltine represents the Debtors are wholly unrelated to the matters with respect to which Sullivan Hazeltine represents the NexPak Debtors.

6. This Supplemental Declaration, together with the Declaration, constitutes

the Declaration of Sullivan Hazeltine required by Sections 327 and 329(a) of the Bankruptcy Code, Bankruptcy Rules 2014(a) and 2016(b) and Local Rules 2014-1 and 2016-1.
